- ❖ Line spacing – 1,5.
- ❖ Paragraph retreat – 1,25 sm.
- ❖ Alignment in width.
- ❖ List of literature according to requirements State standard of Ukraine 8302:2015 – no more than 5 sources.
- ❖ The drawings should be arranged as a single object.
